SECTION 4: First aid measures

4.1. Description of first aid measures

- First-aid measures general : Check the vital functions. Unconscious: maintain adequate airway and respiration. Respiratory arrest: artificial respiration or oxygen. Cardiac arrest: perform resuscitation. Victim conscious with laboured breathing: half-seated. Victim in shock: on his back with legs slightly raised. Vomiting: prevent asphyxia/aspiration pneumonia. Prevent cooling by covering the victim (no warming up). Keep watching the victim. Give psychological aid. Keep the victim calm, avoid physical strain. Depending on the victim's condition: doctor/hospital. Never give anything by mouth to an unconscious person. If you feel unwell, seek medical advice (show the label where possible).
- First-aid measures after inhalation : Remove the victim into fresh air. Respiratory problems: consult a doctor/medical service. Assure fresh air breathing. Allow the victim to rest.
- First-aid measures after skin contact : Rinse with water. Soap may be used. Take victim to a doctor if irritation persists. Wash with plenty of soap and water. Wash contaminated clothing before reuse. If skin irritation occurs: Get medical advice/attention. Specific treatment (see ... on this label).
- First-aid measures after eye contact : Rinse cautiously with water for several minutes. Rinse immediately with plenty of water. Take victim to an ophthalmologist if irritation persists. Remove contact lenses, if present and easy to do. Continue rinsing. If eye irritation persists: Get medical advice/attention.

SECTION 6: Accidental release measures

6.1. Personal precautions, protective equipment and emergency procedures

6.1.1. For non-emergency personnel

Protective equipment : Gloves. Face-shield. Protective clothing.

6.1.2. For emergency responders

6.2. Environmental precautions

6.3. Methods and material for containment and cleaning up

For containment : Contain released substance, pump into suitable containers. Plug the leak, cut off the supply. Dam up the liquid spill.
Methods for cleaning up : Take up liquid spill into absorbent material, e.g.: sand, saw dust, kieselguhr. Scoop absorbed substance into closing containers. Carefully collect the spill/leftovers. Clean contaminated surfaces with an excess of water. Wash clothing and equipment after handling. Soak up spills with inert solids, such as clay or diatomaceous earth as soon as possible. Collect spillage. Store away from other materials.

7.1. Precautions for safe handling

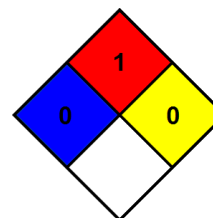
